Appeal Hearing 14th & 15 July 2009**

I write in relation to the above matter. You will recall that you made representations to the Licensing Sub Committee in relation to the application of Pulse Nightclub Street Parties heard on 17th April 2009. At that hearing the application for a premises licence was rejected on the basis of public nuisance. Pulse Nightclub Street Parties Ltd have now appealed this decision and the matter is listed for a hearing on 14th & 15 July 2009 at 11:00am at Cardiff Magistrates' Court, Fitzalan Place, Cardiff.

If in the alternative you do not want to make any representations then I should be grateful if you would inform me of the same.

I look forward to hearing from you with your confirmation that you do wish to make fresh representations or that you wish a local Councillor or a nominated representative to make representations on your behalf.
